Admission Procedure

2025-26

The College offers a robust selection of undergraduate (UG) courses, broadly categorized into three major academic streams: Arts-Social Sciences, Commerce, and Science.

The **Arts-Social Science** stream offers seven core subjects for students to choose from:

- Hindi
- English
- Sociology
- Political Science
- History
- Education
- Home Science

The **Science** stream includes essential subjects crucial for technical and research fields:

- Mathematics
- Physics
- Chemistry
- Zoology
- Botany

The **Commerce** stream offers a comprehensive curriculum, covering all necessary papers and specialisations relevant to the field of business and finance.

The College is committed to adhering to the latest educational reforms and academic standards. All programs are taught in accordance with the **NEP-202 (National Education Policy 2020)** guidelines. The College is officially affiliated with **Maharaja Suhel Dev University, Azamgarh**.

Selection Criteria:

Admission to the various streams and courses offered by the College is primarily **merit-based**. The selection process is designed to ensure fair competition, where an applicant's performance in their qualifying examination is the basic and fundamental criterion for the allocation of available seats.

Reservation Policy:

The College strictly observes and implements the **reservation policy** as stipulated by the **Government of Uttar Pradesh** rules and regulations. This policy ensures equitable access to education for eligible social groups as defined by state law.

Prospective students are required to complete their application process through two distinct online channels:

1. **College Portal:** Applicants must first register and submit their detailed application directly on the official College portal.
2. **SMARTH Portal:** In compliance with university requirements, applicants are also mandated to register and provide their data on the University's designated **SMARTH portal**. This step is essential for official university enrolment, exams and record-keeping.

There is a mandatory examination fee, distinct from the regular course fees, which students must pay directly to the affiliated university. This payment is to be made at the commencement of the scheduled examination period. The college adheres strictly to the fee refund policy guidelines as established and mandated by the University Grants Commission (UGC), ensuring transparency and compliance in financial matters.

Mandatory Uniform and Dress Code Policy

The college maintains a strict and specific dress code that all students must adhere to for regular classes. The wearing of this prescribed uniform is mandatory for all students on every weekday, with the sole exception of Thursday. Students are expected to ensure they are in the correct uniform every day as per the schedule to maintain discipline and collegiate standards.

- **Summer Uniform:** The prescribed attire for the summer season consists of a plain white *kurta* and *pajama*, accompanied by a maroon *dupatta*.
- **Winter Uniform:** During the winter months, students are required to wear the same summer uniform components (white *kurta*, *pajama*, maroon *dupatta*), supplemented by a solid red sweater for warmth.

In addition to the specific uniform, students are required to prominently always wear their official College Identity (ID) card while on campus.
